



Artisans Agreement for Art Object Display and Sales

This agreement secures **inside space for art object display and sales** at the Four Seasons Farmers and Artisans Market in Wheat Ridge, Colorado, allowing the artisan's products to be sold across the counter at the market. The vendor is responsible for maintaining the product inventory and assuring that all items are priced and marked with the vendors assigned code.

Vendor Seasons Fees: \$25 per season. Seasons are defined as:

Summer-Fall - June thru October and Winter-Spring – November thru May

The season fee secures display space for the season to provide a consistent display location.

Season fees are due at the beginning of this agreement. Subsequent season fees are due at the beginning of each season.

Sales Commission Fees:

The market fee for handling sales is 40%. The vendor will be paid 60% of the total amount all of the sales on a weekly basis. The vendor will not need a state or local sales tax license. The market will complete all appropriate sales reports and pay sales taxes to the proper jurisdictions.

Pre-authorization for immediate sales discount: The Artisans Signature in this section authorizes the market to negotiate a discount for a specific item sale of up to 10% in response to a specific offer from a prospective buyer. This option recognizes that some art purchases are spontaneous and sales can benefit from a promptly completed negotiation and closure. Any discounts larger than 10% must be approved in advance by the Artisan.
